FCC

While the Federal Communications Commission has the final word on all things E-Rate, they do not have much information in a user-friendly format. Perhaps the most useful page from the FCC website is: www.fcc.gov/encyclopedia/e-rate-schools-libraries-usf-program. It has useful links, and a list of appeal decisions.

USAC

The USAC website is full of good information, and it has gotten easier to find. Here are some of the important pages:

Note that on that page, above the picture of the library books is a purple bar that says "APPLICANTS." That is actually a button that will show you the steps of the application process, with links to more information from there.
